

Instructions

SixFifty built our free Utah Gender Marker Change tool to simplify the gender marker change process as much as possible. But even with technology the process will take time, and includes a \$375 court fee. If you can't afford to pay the fee, our tool can help you apply for a fee waiver. You can learn more about fee waivers [here](#).

Many court documents may refer to the process of changing your gender marker as a "Sex Change." SixFifty knows, as do you, that isn't the case. A court can't change your sex or your gender, only the legal indications of it— your gender marker. For this reason, SixFifty refers to this process as "Gender Marker change." When you see "Sex Change" on any Utah forms, or you hear it from a judge or court employee, know that they're talking about this process—legally changing your gender marker.

These instructions will help you:

1. Request a Department of Corrections Certification Regarding Sex and Kidnap Offender Registry and Child Abuse Offender Registry (**only required if you're also changing your name**)
2. Complete the documents in this email, including "Evidence of Appropriate Clinical Care"
3. File your documents
4. Prepare for your hearing (and find legal help, if needed)
5. Get a court order for your new gender marker, plus certified copies
6. Use your court order to update your government documents with your new gender marker

Read through all of these instructions before proceeding.

Request Department of Corrections Certification

This step is only required if you're also changing your name. If you're changing only your gender marker, you can skip this step.

The first step in the name change process is to request a certification from the Utah Department of Corrections Offender Registration Program showing whether you're on the Sex and Kidnap Offender Registry or the Child Abuse Offender Registry.

For most people, it's easier to scan and email the letter. If you don't have a scanner, and don't know how to use your smartphone as a scanner, fill out the form and mail it with a self-addressed and stamped envelope to the Offender Registration Program at the address listed below. Allow up to 3-5 weeks for the Offender Registration Program to complete the form and return it to you.

- If you are on the Child Abuse Offender Registry you cannot change your gender marker.
- If you are on the Sex and Kidnap Offender Registry you must convince the court that it is not against the public interest for you to change your gender marker

Instructions

1. Complete the form. It's the one that says "Department of Corrections Certification Regarding Sex and Kidnap Offender and Child Abuse Offender Registries – Adult" in the top right corner.
2. **Don't** complete the section that says "This section to be completed by Offender Registration Program staff."
3. **To email the forms:** Scan the documents and email them to: registry@utah.gov. If you don't have a scanner, there are apps available for most smart phones and tablets that allow you to use your device camera as a scanner. If you use this method, skip ahead to step 10.
4. **To mail the forms:** Gather two envelopes—one for sending the form to the Department of Corrections, and one for them to mail you back the certification.
5. Write your address on one of the envelopes. This is the envelope that the Department of Corrections will use to mail you *back* your completed certification.
6. On the other envelope, write this address:

7. Put a stamp on each envelope. Place the envelope with your address inside the envelope with the Offender Registration address.

8. Put the completed form in the envelope with the Offender Registration address
9. You must mail this form to the Offender Registration Program. They do not have an office open to the public. If you haven't sent a letter in a while, [here's a helpful guide](#).
10. The Offender Registration Program staff will fill out their section and will return the completed form to you using the envelope you provided.
11. When you get the form back, it's time to file your paperwork.

Complete your Documents

Print the documents that SixFifty emailed you, and review them for accuracy. Even if you plan to file your petition by email, it's a good idea to print the documents for your records. Ensure all of your answers are correct to the best of your knowledge.

The documents you'll file with the court are:

- Department of Corrections Certification (if you're changing your name)
- Cover Sheet for Probate Actions
- Motion to Waive Fees and Order on Motion to Waive Fees (only if you're requesting a fee waiver)
- Petition for Name or Sex Change
- Order on Petition for Name or Sex Change Change
- Notice of Pronouns (if you chose to generate one)
- Evidence of Appropriate Clinical Care (like a letter from your doctor)

Sign and date these documents:

- Petition for Name or Sex Change.
- Motion to Waive Fees (if you chose to generate one)
- Notice of Pronouns (if you chose to generate one)

You don't need to sign any other forms yet. Contact your doctor and ask them to complete your Evidence of Appropriate Clinical Care letter. If your doctor prefers to write the letter themselves, they can use the letter from SixFifty as a guide.

Set your other documents aside for later. Save the file that you downloaded from SixFifty and the email we sent you, in case you lose your documents.

You'll only need to use the Notice of Hearing if there's someone who should be notified of your Gender Marker Change, like a spouse or military commanding officer.

If you can, place the documents you're filing in a manilla folder. If you don't have a folder, try to keep them together with a paperclip. The court will accept your paperwork without a folder or paperclip, but they prefer that you use them.

File your paperwork

"Filing" sounds complicated, but it just means giving documents to the court. You can deliver your papers to the court in person, by mail, or by [email](#). Not all courts allow for email filing, and the courts that do may stop at any time. If possible, file in person. It will be helpful when you attend your hearing later.

Filing by email may be more convenient for some people, but it can also be complicated. If you're not comfortable using Microsoft Word, attaching files to emails, etc, file in person or by mail instead. If you have any trouble filing your documents, please email probono@sixfifty.com.

Utah courts charge a \$375 filing fee to change your gender marker. You'll need to either include payment, like a check or money order, or a Motion to Waive Fees.

If you're filing by email, the court will let you know how to pay your fee—usually by phone with a credit card. If you're filing in person or by mail, make your check or money order payable to:

If you're required to file a Notice of Hearing because you are on the Sex and Kidnap Offender Registry, you should work with an attorney on your petition. You can see more about attorneys in Utah under the section "Court Hearing."

Where to file

When to file

You should file your petition as soon as you can after receiving your Department of Corrections certification.

Most Utah courthouses are open from 9am to 5pm, Monday through Friday. Some courts open as early as 6am and close as early as 4:30pm. Some courts do not accept filings shortly before closing. [Contact court staff](#) to ask about local procedures.

Attend your Hearing

After you file your documents, the court will schedule a hearing. You must go to your hearing. At the hearing, the judge may ask you questions about your gender marker change request.

You don't have to work with an attorney, but if you'd like an attorney to help you file your documents, or to join you at your hearing, these are some organizations who can offer affordable help.

Requesting Old Records be Sealed

By default, an "amendment history" will appear on records like your birth certificate. This means that your old gender marker and your new gender marker will both appear on your birth certificate, unless requested otherwise in your documents *and* at your hearing. If you indicated that you *do not* want your old gender marker to appear on your birth certificate along with your new gender marker, then SixFifty has added that request to your court order and petition documents. However, you must also *verbally* request this during your hearing. This request may sound similar to:

"Your Honor, I request that amendments to the record of my gender marker be sealed, so that the amendment history will not appear on the face of an updated birth certificate. I want the Office of Vital Records to make no mention of my original gender marker."

Also explain to the judge why you don't want your old gender marker on your birth certificate. Your reason can be that you simply don't want your birth certificate to show your old gender marker.

Obtain Court Order and Certified Copies

After your hearing, you'll receive a court order for your gender marker change. If you requested that your records be sealed, and the judge granted your request, it will cost \$40 to seal records. You will pay this fee when you get your new birth certificate. Learn more about that under the "Birth Certificates" section.

You'll need at least 3 certified copies of your court order to change your most important identification documents — Driver License/State ID, Birth Certificate, and Social Security Card. The court may charge a fee of \$4 per certification and \$0.50 per page of your order. Ask the court clerk for these certified copies.

Use Court Order and Certified Copies to Change your IDs

Once you have your new gender marker, you should update your most important identification documents— Driver License/State ID, Social Security Card, and Birth Certificate.

Driver License or State ID

Information about getting a driver license or a Utah ID card with your new gender marker is available on the [Driver License Division website](#). You will need to bring a copy of the certified court order that you receive from the court.

Here are the steps to change your gender marker on your Driver License or State ID:

1. Complete the [online application for a replacement ID](#)
2. When complete, you'll be able to schedule an appointment to visit a [Driver License office](#).
3. Bring your current driver license or state ID if you have it, and your court order.
4. Have your photo taken upon arrival.
5. Pass an [eye test](#) (for driver license, not for an ID card).
6. Submit a nonrefundable fee of \$23.00.
7. If your Utah residence address has changed from what is on your current driver license, you'll need (2) documents showing your Utah residence address. Visit the [Required Documentation](#) page for what is acceptable proof. You can also submit the address change [online](#) to avoid having to provide proof when coming into the office.

Social Security Card

The fastest and easiest way to change your gender marker on your Social Security card is by using the Social Security Administration's [online application](#). If you have any questions, you can call the Social Security Administration's toll free number, 1-800-772-1213.

After you submit your online request, you must visit your [local SSA office](#) within **45 calendar days**. Bring these documents with you:

- Your new driver license / state ID (not a temporary or copy)
- Your court order

If you prefer to apply by mail, follow the steps listed on the [Social Security Administration's website](#).

Birth Certificate

To request a birth certificate with your new gender marker, you can [create a free Utah.gov account](#) and begin the process online or follow the steps below. If you need help requesting a birth certificate online, you can get support [here](#).

For birth certificates issued in states other than Utah, consult the [Where to Write for Vital Records](#) page for contact information.

Listed below are all items that are required to process a court ordered gender marker change request without delay:

1. Complete a birth certificate application. You can apply [online](#) or with [this application form](#).
2. Fill out and sign a [Court Order Amendment Form](#). SixFifty's added helpful explanations further down in these instructions.
3. Include a Certified Copy of your Court Order
4. Correct fees - The fee to register an amendment and 1 copy of the corrected birth certificate is \$27. If you're requesting a birth certificate with *only* your new gender marker, an extra \$40 will apply to "seal the record" of your old gender marker. You can also expedite the process for \$15, which gives your order first priority, but does not guarantee a specific timeline.
5. Copy of valid ID. Acceptable forms of identification are listed in the table below. You only need 1 form of identification from the "Primary" column. If you don't have any ID in the primary column, you'll need two forms from the "Secondary" column.

How to complete your Birth Certificate Application and Affidavit to Amend

SixFifty hopes to automate these forms soon. For now, use these helpful guides.

[Birth Certificate Application.](#)

You'll notice that the form provided by the state pre-populates some fields. It shows "1" for the number of certificates, and \$22 for the fee. The correct fee for an updated certificate is \$27, and you can request more copies if you want to.

SixFifty contacted the Office of Vital Records for guidance. They recommend crossing out anything you'd like to change. First, cross out "\$22" and write in "\$27." If you want to expedite the application, write "\$15 expedite" in the green square shown below. If you don't want your old gender to appear on the certificate, and your court order says so, write "\$40 seal amendment" in the rectangle.

Contact the people and the institutions you work with and ask what they need to make your gender marker change official in their records. Institutions like banks, investment companies, and insurance companies may have you complete their own form, and will also want proof of your identification.

Update Legal Documents

Update other legal documents like your will, advance health care directive, and power of attorney for financial matters to show your new gender marker. If you don't have a will, advance care directive, or power of attorney, email probono@sixfifty.com for information about our free tools.
